1. Resolutions and Presentations

The board approved a resolution honoring winners of 2012 National History Day contest. The board, with two members abstaining, approved another resolution that "encourages CSCOPE, and any other provider of instructional materials, to participate in the SBOE review process to ensure quality materials are in our classrooms."

The board adopted the four-year rule review of Chapter 101, which deals with rules governing the student assessment program.

3. Proposed New 19 TAC Chapter 117, <u>Texas Essential Knowledge and Skills for Fine Arts</u>, Subchapter D, <u>Elementary</u>, Subchapter E, <u>Middle School</u>, and Subchapter F, <u>High School</u> (Second Reading and Final Adoption)

The State Board of Education gave final approval to revised Fine Arts Texas Essential Knowledge and Skills. The board did so after amending the standards to include specific references to Middle School 2 and 3 Jazz Ensemble. The new standards are to be implemented beginning with the 2015-2016 school year.

The board approved on first reading and filing authorization additional course offerings that would allow students to satisfy the fourth mathematics and the fourth science credit requirements under the Recommended High School Program and the Distinguished Achievement Program. 5. Proposed Revisions to 19 TAC Chapter 130, Texas Essential Knowledge and Skills for Career and Technical Education, Subchapter A, Agriculture, Food, and Natural Resources, Subchapter H, Health Science, and Subchapter O, Science, Technology, Engineering, and Mathematics

(First Reading and Filing Authorization)

The board approved on first reading and filing authorization revisions to 19 TAC Chapter 130, Texas Essential Knowledge and Skills for Career and Technical Education. The board amended

Subchapter A, Agriculture, Food, and Natural Resources, §130.6, Veterinary Medical Applications (One Credit), and §130.12, Advanced Environmental Technology (One Credit), so that the courses can be added as options to satisfy the fourth science graduation requirement. The proposal adds new §130.210, Human Body Systems (One Credit), to Subchapter H, Health Science, as an additional option to satisfy the fourth science graduation requirement. It adds new §130.375, Principles of Engineering (One Credit), and new §130.376, Digital Electronics (One Credit), to Subchapter O, Science, Technology, Engineering, and Mathematics, as additional options to satisfy the fourth mathematics graduation requirement.

6. Proposed New 19 TAC Chapter 111, <u>Texas Essential Knowledge and Skills for Mathematics</u>, Subchapter C, <u>High School</u>, §111.46, <u>Discrete Mathematics</u>, <u>Adopted 2013 (One-Half to One Credit)</u>

Board members approved for first reading and filing authorization a proposal that would add Discrete Mathematics, which is currently an innovative course, to the list of course options that satisfy the fourth math graduation requirement.

7. Proposed Revisions to 19 TAC Chapter 126, <u>Texas Essential Knowledge and Skills for Technology Applications</u>, Subchapter C, <u>High School</u> (First Reading and Filing Authorization)

The board approved minor modifications to a course called Robotics Programming and Design so that the course can be added as an option to satisfy the fourth mathematics graduation requirement. This item also included technical changes that move the course Discrete Mathematics from the innovative course category to the mathematics course section of the rules.

8. Proclamation 2015 of the State Board of Education Advertising for Bids on Instructional Materials

The board approved Proclamation 2015, which advertises for bids on new instructional materials to be used by school districts and open-enrollment charter schools beginning in school year 2015-2016. The proclamation contains Texas Essential Knowledge and Skills (TEKS) in each subject for which bids are being invited, specifications for providing computerized files to produce Braille versions of adopted instructional materials, and a schedule for the adoption. The subjects and grade levels covered by Proclamation 2015 include social studies, grades K-12; mathematics, grades 9-12, and fine arts, including Middle School Jazz Ensemble 2 and 3 due to changes made earlier at this meeting. Instructional materials submitted under Proclamation 2015 are scheduled for adoption by the SBOE in November 2014.
