#### **A Quick Refresher About Innovative Courses**



- 1. Part of State Board of Education (SBOE) process for courses that are not included in the Texas Essential Knowledge and Skills (TEKS)
- 2. May only satisfy state elective credit for high school graduation
- 3. Require local board approval to implement (LEAs)
- 4. Are high school courses that are innovative in nature and meet student needs

#### **Application Cycle Extenuating Circumstances**

- Allows for approved courses to be implemented beginning in 2024-2025
- Requirements:
  - Course pilot complete prior to 2023-2024 school year (except for CTE courses designated for a program of study)
  - Local school board approval to submit an application (LEAs)
  - Meet with TEA staff to be considered

## Application Cycle Extenuating Circumstances, contd.

Information that will be required for extenuating circumstances:

- Course title
- Contact information
- Brief course description
- Pilot enrollment, location, and year(s) except for <u>CTE courses</u> designated for a program of study
- Explanation of why the application should be considered an extenuating circumstance

#### **Rule Changes for Innovative Courses**

#### Rules That Did Not Change - Innovative Course Applications

- Innovative courses do not duplicate TEKS-based courses.
- Applications include
  - award of credit;
  - a description;
  - a justification;
  - pilot data (new courses);
  - recommended activities, resources, and assessments;
  - Texas teacher certifications; and
  - required trainings (with cost).
- Innovative courses require local board approval to submit an application.

# Recent Rule Changes for Innovative Course Applications

Previous Rules	Amended Rules
Courses approved by either SBOE or Commissioner of Education	All courses are approved by <u>SBOE</u> .
All new courses require a pilot	All new courses, <u>except for courses designated for a TEA-authorized CTE program of study</u> , require a pilot.
N/A	New courses are approved for three years and renewals for five years.
LEAs may offer innovative courses without modifications with the approval of their local board of trustees	LEAs may offer innovative courses without <b>deletions</b> with the approval of their local board of trustees.
N/A	All recommended resources must be submitted to TEA for SBOE review.




#### **Biennial Sunset Review of Innovative Courses**

- New requirement established by the SBOE
- Review occurs every two years
- For innovative courses that have been approved for at least three years and meet at least one of the following criteria:
  - zero enrollment for the previous two years
  - average enrollment of less than 100 students statewide for the previous three years
  - student enrollment at an average of fewer than 20 districts or charter schools statewide for the previous three years
  - duplicative of another innovative or TEKS-based course
  - approved for implementation as a TEKS-based course
- Outcome of review: SBOE decision to continue or retire each course



#### **Biennial Sunset Review of Innovative Courses Timeline**





#### In Summary

- 1. The next innovative course cycle opens in February 2024 for implementation in the 2025-2026 school year.
  - Extenuating circumstances may be considered for an earlier cycle.
- 2. Certain rules have changed:
  - SBOE approvals
  - CTE pilot requirements
  - Approval term lengths
  - Standards without "deletions"
- 3. The SBOE will conduct a biennial sunset review of innovative courses.
