Due to the size of EISD, the Superintendent and Federal Programs Director both work directly with the campus, campus administration and have a personal knowledge of campus/student needs as well as potential issues or barriers. The Superintendent will work personally with campus administration, leadership teams as well as individual stakeholders to ensure fidelity in the creation of the Targeted Improvement Plan. The LEA will ensure that the Targeted Improvement Plan will be based on data from various sources including the District Self-Assessment and ESF Diagnostic. The LEA will oversee that as the Targeted Improvement Plan is completed that areas identified as in need of improvement are maintained as the focus of the implementation.

By having a scheduled and consistent meeting calendar to determine the validity and progress of both short and long term goals through data collection of both formative and summative assessments the LEA can gather evidence of the success of program initiatives. In an effort to provide continual support and effective communication the DCSI will visit the campus daily so that all staff feel supported and their efforts valued as they implement the initiative with fidelity.
