The LEA will continue to utilize the current Targeted Improvement Plan, but will make appropriate adjustments to the plan. The LEA will continue to employ a District Coordinator of School Improvement (DCSI) that will monitor implementation of the Targeted Improvement Plan. The LEA will continue to contract with a consultant to ensure that all deadlines and requirements are met.

Describe how the LEA will monitor schools receiving the ESF-Focused Support Grant, including how the LEA will: (a) Monitor a web-based improvement plans upon submission and during implementation, and (b) Implement additional action following unsuccessful implementation of such plan after the first year of the grant cycle.

The LEA will monitor the Targeted Improvement Plan by collecting artifacts based on the levers in the Effective Schools Framework. The LEA will monitor the barriers each quarter to establish a growth measure of each lever to ensure that appropriate progress is being attained. If progress is slow to or not being attained, adjustments will be made to the action steps in the plan.

The LEA has used the Effective Schools Framework for the past two years, and has established growth measures for each of the following levers:

1.1 Strong School Leadership and Planning

The LEA will establish strong roles and responsibilities within the leadership team to ensure that the plan's vision is portrayed through all members of the team.

4.1 High Quality Curriculum

The LEA will establish clear goals for teachers in aligning purchased materials to the TEKS by using the TEKS resource system.

5.3 Effective Instruction

The LEA will define clear objectives and differentiated instruction for all teachers and students.

Budget Narrative

The LEA will use the appropriated monies to staff a math interventionist. The LEA will also use the grant monies to contract with a Targeted Improvement Plan advisor to assist with the continued development of a web-based improvement plan. The LEA will use a portion of the grant for professional development for the school leadership team. Based on our TIL readiness assessment, our leadership team will partner with the local ESC for deeper training in Lesson Alignment and Formative Assessment and Observation and Feedback. The LEA will use the grant money to purchase various technology supplies to allow teachers to ability to use tablets with their interactive boards. These tablets will allow the teachers more mobility throughout their classrooms while teaching lessons and being able to interact more with their students. The lower elementary levels will purchase iPads for their hands on learning devices.

The LEA will align this grant program to the Title I, Part A Improving Basic Programs grant that allows for reading intervention for the elementary students, and allows the LEA to purchase other supplemental programs to help with any gaps that may be established in the learning environment. The LEA will align this grant program with the Title II, Part A Preparing, Training, and Recruiting High Quality Teachers and Principals grant that allows for stipends to be paid to teachers in higher need areas, such as math and science. This grant also allows for more in-depth training for our school principals.
