Discussion and Action on Extending the Timeline on the Texas edTPA Pilot

DISCUSSION AND ACTION

SUMMARY: This item provides the SBEC the opportunity to extend the edTPA performance assessment pilot period one year; from September 1, 2021 to September 1, 2022.

STATUTORY AUTHORITY: The statutory authority for the classroom teacher class certificate structure is Texas Education Code (TEC), §§21.003(a), 21.031, and 21.041(b)(1), (2), and (4), 21.041(c), 21.044(a), 21.0441, 21.0418(a).

FUTURE ACTION EXPECTED: Texas Education Agency (TEA) staff anticipates presenting an edTPA pilot update to the Board at each SBEC meeting with an official review by the Board prior to September 1, 2021.

BACKGROUND INFORMATION AND JUSTIFICATION: At the July 2019 SBEC meeting, the Board approved the edTPA performance assessment pilot to run two consecutive years. As a result of that meeting, SBEC rule requires that the Board review the edTPA pilot data no later than September 1, 2021. Due to the impact of COVID-19 on educator preparation and those impacted by the execution of the performance assessment, TEA staff recommends that the SBEC extend the pilot period one year, to include a third pilot year. TEA staff will continue to provide updates to the SBEC at each meeting.

<u>Update and Staff Recommendation</u>

COVID-19 has significantly impacted the education landscape in Texas, including educator preparation. Its onset has required local education agencies and educator preparation programs to engage in rapid change to meet the demands of the moment while continuing to prioritize the needs of students first. Since February 2020, TEA staff have worked in close collaboration with 35 educator preparation programs to plan for the pilot implementation of edTPA during the 2020–2021 academic year. These programs have worked to implement broad scale programmatic changes due to COVID-19 while also working to implement the edTPA, which also necessitates programmatic change.

Since the onset of COVID-19, the SBEC charged TEA staff to remain sensitive to the needs of candidates, programs, and school districts during this time and offer support and flexibility whenever possible. With this in mind, TEA staff is recommending that the Board extend the edTPA pilot for a third year, ending September 1, 2022 rather that September 1, 2021.


Extending the edTPA pilot for a third year would demonstrate sensitivity to the reality of the situation and allow for a longer runway for those candidates and preparation programs who are interested in piloting the edTPA. The extension would also allow Sam Houston State University additional time to collect candidate data in their study.

Throughout the extension of the pilot, TEA staff would continue to provide ongoing support to programs and work with Sam Houston State University as they conduct their study.

edTPA Next Steps

The SBEC approved a two-year pilot of the edTPA, with the expressed purpose of gathering data on the impact of edTPA implementation on Texas candidates. The Board has directed TEA staff to collect and analyze data related to the implementation of the edTPA across both years of the pilot to make decisions grounded in Texas data related to edTPA implementation going forward. The pilot period does not denote a start and end time for educator preparation programs or candidates but provides a time period to collect data to allow SBEC to determine the impact and effectiveness of the exam for certification purposes. If the SBEC approves the pilot period extension, programs will have a third year to pilot the edTPA.

At the May and July 2020 SBEC meetings, TEA staff provided an update on the edTPA and shared that there would be a summary of year one edTPA pilot data for the Board's review at the October 2020 SBEC meeting. Given the recommendation to extend the pilot period, SBEC Board Chair, Dr. Art Cavazos, directed staff to provide the Board with a timeline in this agenda item and then to bring a summary of year one data to the Board for their review in December 2020. The proposed edTPA pilot timeline that is inclusive of a third-year pilot can be found below. In addition, a detailed version of the timeline can be found in the attachment.



Currently, all EPPs that participated in the year one edTPA pilot have access to their programmatic edTPA data and have been provided support in leveraging the data for continuous improvement.

With the proposed action, TEA staff would continue to:

- gather data on Texas pilot implementation of the edTPA,
- support preparation programs and candidates who are participating in the pilot,
- provide the SBEC with continual updates at SBEC meetings,
- work with Sam Houston State University on their study,
- provide an update on the outcomes of the second-year pilot in Fall 2021, and
- an analysis of all three years of implementation in Fall 2022.

If the SBEC approves the extension of the pilot period, TEA staff will bring a rule action item at the December 11, 2020 meeting to codify the new review date of September 1, 2022.

ASSOCIATE COMMISSIONER'S RECOMMENDATION:

Approve the extension of the edTPA pilot period and direct TEA staff to bring proposed rule language at the December 11, 2020 SBEC meeting to codify the extension of the pilot period in the Texas Administrative Code.
