## **TEA releases 2017 Community and Student Engagement ratings**

AUSTIN – The Texas Education Agency released the 2017 Community and Student Engagement (CaSE) ratings for the state's school districts, charters, and campuses today.

The Texas Education Code (TEC) requires all districts and charters to evaluate their own performance, as well as that of each of their campuses, in community and student engagement. Districts must assign—both to themselves and to each of their campuses—one of four performance ratings: Exemplary, Recognized, Acceptable or Unacceptable.

In 2017, 1,200 of 1,201 school districts and charters in Texas reported a locally assigned overall rating of Acceptable or higher. In addition, more than 99 percent of campuses (8,451 out of 8,499) received a locally assigned rating of Acceptable or higher.

While districts must assign locally determined performance ratings for themselves and all their campuses, ratings are not required for budgeted (non-instructional) campuses, Disciplinary Alternative Education Program (DAEP) campuses, Juvenile Justice Alternative Education Program (JJAEP) campuses, and facilities operated by the Texas Juvenile Justice Department.

Each district also indicates whether it and each of its campuses have complied with statutory reporting and policy requirements.

Local committees determine the criteria that districts use to evaluate performance, assign and performance ratings, and evaluate district compliance with statutory reporting and policy requirements. Districts and charters were required to have posted their locally assigned ratings and compliance status on the school district's website by August 8, 2017.

The agency is also required to report the performance ratings and compliance statuses on its website. The agency meets this requirement by the annual release of the Texas Consolidated School Ratings (TCSR) reports.

The TCSR combines performance information from several different sources and reports it for each Texas public school district and campus. It contains ratings for three areas:

- State academic accountability ratings and distinction designations for 2012–13, 2013–14, 2014–15, 2015–16, and 2016–17
- State financial accountability ratings reported in School Financial Integrity Rating System of Texas (School FIRST) for 2012–13, 2013–14, 2014–15, 2015–16, and 2016–17
- Locally assigned Community and Student Engagement ratings and statutory compliance statuses for 2013–14, 2014–15, 2015–16, and 2016–17

House Bill 22, which became law on June 15, 2017, repealed TEC, §39.0545 and §39.0546, the statutory requirements for CaSE ratings. Accordingly, this will be the last year that CaSE data will be collected from districts and reported on the TCSR. Districts received news of the repeal of the CaSE reporting requirements on June 23, 2017.
